1. The purpose of this public hearing is to adopt the proposed millage rate for 2008-2009 and schedule the tentative budget hearing.

The Glades County BCC prior year (2007-2008) millage rate is : 9.1367  
General Fund                    9.0367  
Transportation Trust            .10

The Glades County BCC current year rolled-back rate is 9.5021.

The BCC MSTU Law Enforcement prior year (2007-2008) millage rate is : 1.95

The BCC MSTU Law Enforcement current year rolled-back rate is 2.0286.

2. Motion to adopt current year proposed millage rate for BOCC:

10 mills - Requires 5 - 0 vote (unanimous)

or

9.1367 mills - Requires 4 - 1 vote (supermajority 2/3)

or

8.5236 mills - Requires 3 - 2 vote (majority)

3. Motion to adopt current year rolled-back rate for BOCC of 9.5021.

4. Motion to adopt current year proposed millage rate for MSTU for Law Enforcement:

2.1211 mills - Requires 5 - 0 vote (unanimous)

or

1.95 mills - Requires 4 - 1 vote (supermajority 2/3)

or

1.6620 mills - Requires 3 - 2 vote (majority)

5. Motion to adopt current year rolled-back rate for MSTU for Law Enforcement of 2.0286.
